

# Child Protection AoR Localization Dashboard - Myanmar

July – December 2023

## Objective:

This dashboard has been developed for tracking progress of Child Protection AoR towards localization. The dashboard will also sensitize child protection AoR in Myanmar to issues of localization and provide the basis to create an action plan towards increasing meaningful participation of local and national actors.

## Methodology:

- Over 35 CP AoR partners were invited to participate in a survey in February 2023.
- Survey period: July – December 2023
- Survey was conducted around 5 pillars – Governance and decision making, Influence and Participation, Partnerships, Funding, Institutional capacity.

## Conceptualization of localization in the survey:

Q: Is there collaboration in the coordination group to collectively address the capacity issues that are faced by partners?

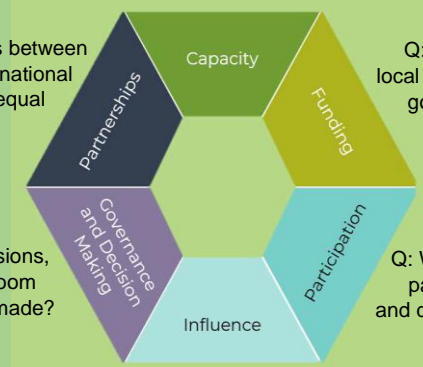
Q: Are partnerships between international and national organizations equal

Q: Does funding go directly to local and national actors, or is it just going to international actors?

Q: Who makes decisions, and who is in the room when decisions are made?

Q: Who actually has power to participate in coordination and decision-making processes?

Q: Who actually has power to influence in coordination and decision-making processes?

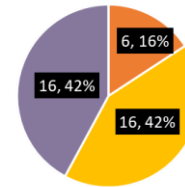

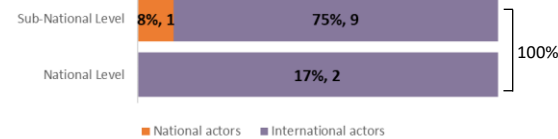

- # from Local Organisations



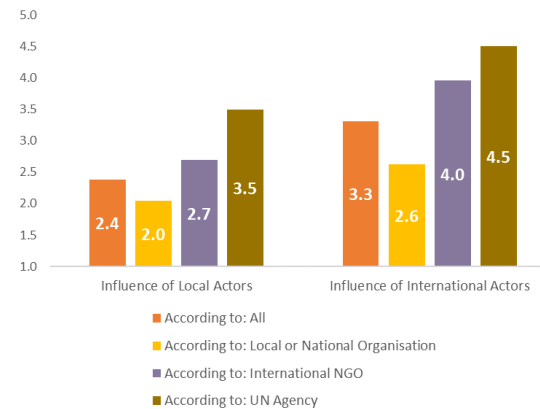
### Leadership scenario in National and Subnational Level



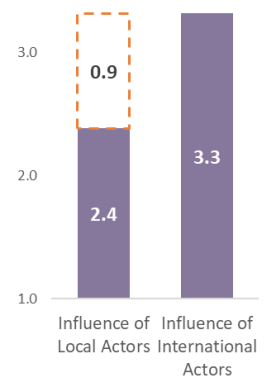
## Influence

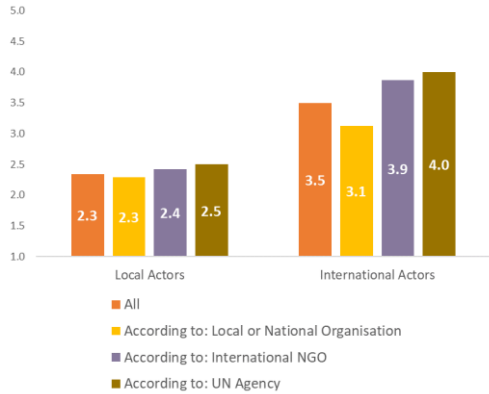

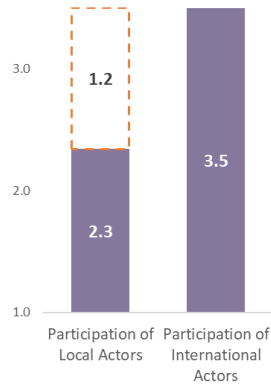
## Participation

Participation Gap



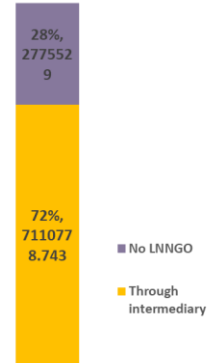
## Funding

Around **4 in every 10** Children were reached by Local/National Actors (Based on 5Ws reporting (July to December 2023))

Total Children reached by Local/National actors 237,261 (38%)



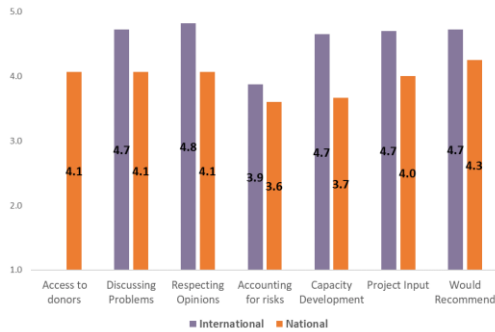
Funding to Local and National NGOs, in USD



0% fund were reported from Direct Donor to Local/National NGOs

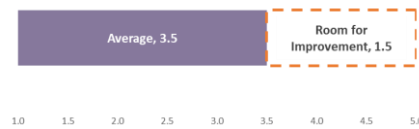

Perception of Partnership with L/NGOs by Type of Actors



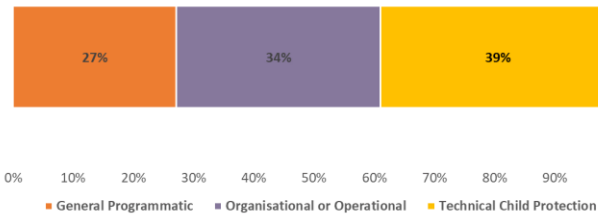

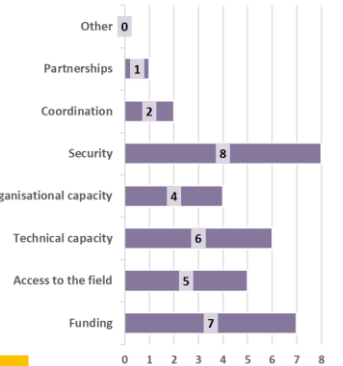

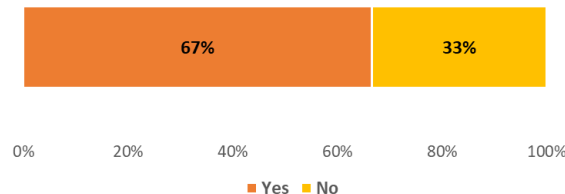
Type of Capacity Strengthening Activities Provided to Local and National Actors by UN Agencies and INGOs



Top Constraints of Local and National Actors



Are UN agencies/INGOs actively approaching Local and National Actors' Staff?



**Access to donors** = L/NGO attends meetings with the donor, alongside UN/INGO partners (3 = Sometimes, 4 = Frequently, 5 = Always)  
**Discussing Problems** = how comfortable L/NGOs are to approach UN/INGO partners to discuss problems (3 = Somewhat comfortable, 4 = Quite comfortable, 5 = Very comfortable)  
**Respecting Opinions** = UN/INGOs respect L/NGOs partners' point of view (3 = Some respect, 4 = Respectful, 5 = Very respectful)  
**Accounting for L/NGOs' risk** = Risks to L/NGO staffs' have been adequately taken into account in the partnership (3 = Moderately, 4 = Considerably, 5 = Completely);  
**Capacity Development of L/NGO staffs** = by UN/INGO partners (3 = Ad hoc capacity development for organization, 4 = Occasional capacity development for organization, 5 = Work very well on capacity development together)  
**Inputs into Project design** = consideration of L/NGOs partners' inputs into project design (3 = Some collaboration, but donor leads, 4 = Work together but donor/UN/INGO decides, 5 = Work together collaboratively as equals)  
**Would recommend** = if L/NGOs and UN/INGO partners would recommend others about each other (3 = Unsure, 4 = Likely to recommend, 5 = Very likely to recommend)
